Greetings:

On behalf of our 2431 retired members I would respectfully ask for a review of members benefits as it relates to the "Will" benefit. Many of our members have expressed their frustration is not being able to utilize this benefit. The benefit, for retired members, is only available to those who reside in Suffolk County. In excess of 1200 of our members reside outside of New York State and others reside outside Suffolk County. This leaves most retirees ineligible for this benefit.

Active members have the opportunity of utilizing their personal attorney for wills. They are eligible for a reimbursement of \$50.00 every three years. We would like to see this reimbursement benefit made available to all benefit fund members including retirees. Can you please review this matter and advise if or why this benefit cannot be expanded to all members.

I look forward to your response on behalf of our members.

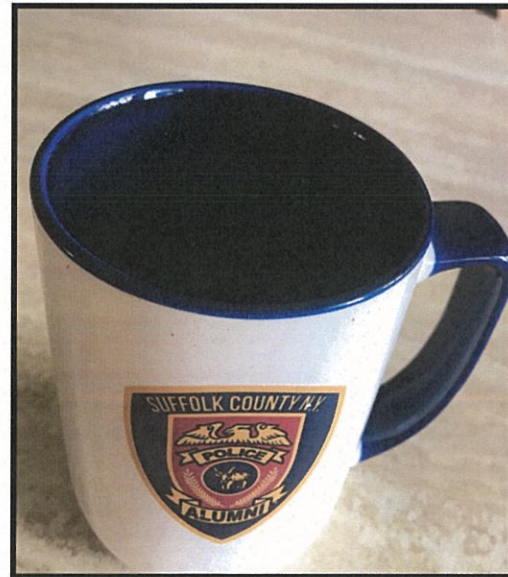
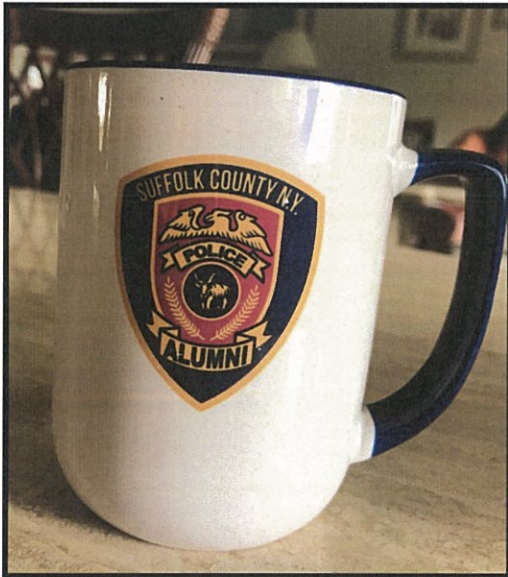
VICE PRESIDENT

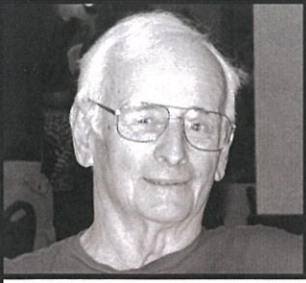

ADMINISTRATOR'S MESSAGE

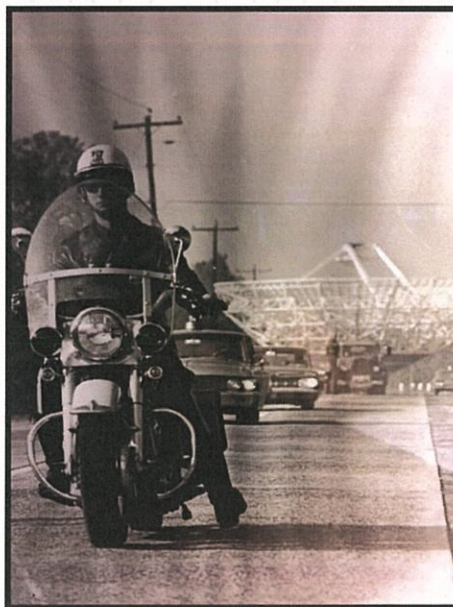
